He is a passionate learner and has done LLB from Calcutta University and Diploma in Social Work from IISWBM. He has also done MBA in HR, Diploma in Training & Development form ISTD and PhD in Management.

During his 26 years of service as a Labour Administrator he has served in many capacities including 2 stints at State Labour Institute as Assistant Director and Joint director and Commissioner of Employees' Compensation.

He has conducted sessions on Labour Laws and Behavioural skills in many organizations including NUJS, IIT (Kharaqpur), CMA, MDI (Murshidabad), ICC, Administrative Training Institute, ISTD, NHRDN etc. He was the first Editor of 'Labour Bulletin' published by the State Labour Institute, Kolkata and brought out 2 special issues on Labour Laws of West Bengal Labour Gazette 2011.
